CHILD'S REGISTRATION

INFORMATION UPDATES

MEDICAL EXAMINATION CONSENT

Future International Nursery has a licensed nurse on site at all times. Additionally, a visiting doctor carries out medical checkups on a weekly basis and examines in priority the children who are unwell, or show reasons for concerns.

I understand that all such examinations are supervised by the nurse and we give our consent for our child to receive regular physical examinations.

EMERGENCY TREATMENT CONSENT

In case an accident or injury happens to our child and we cannot be reached at the emergency numbers indicated in this application, we hereby allow FIN management to take all necessary steps to ensure appropriate medical treatment is provided to our child, either by FIN nurse or at a government hospital or clinic.

FIELD TRIP CONSENT
